## Sub: Illegal Activity and sale of "Neolacta" Continues

Dear Madam,

The Breastfeeding Promotion Network of India (BPNI) is a 30 -year old national non- profit organisation working on protection, promotion and support of breastfeeding in India. BPNI has been notified in the official Gazette to monitor the compliance with the *Infant Milk Substitutes Feeding Bottles, and Infant Foods (Regulation of Production, Supply and Distribution) Act 1992, and Amendment Act 2003.* Ever since BPNI has been monitoring and reporting its violations to the Government of India.

Since BPNI has been at the forefront for advocacy and training on policy and programmes related to supporting women for breastfeeding, we like to bring to your attention the illegal sale of mother's milk by 'Neolacta Lifesciences.' They are doing commercial processing and selling mother's milk.

In a response to the Parliament question 2225, on "Commercialisation of Mother's Milk", recently you had stated as:

"(a) to (f): Food Safety and Standards Authority of India (FSSAI) has informed that Food Safety and Standards Act, 2006 and Rules and Regulations do not cover the commercial processing/selling of human milk.

Ministry of Ayush has informed that State Licensing Authority of Karnataka has issued Ayush license regarding mother's milk. In this regard, Ministry of Ayush has directed State Licensing Authority of Karnataka vide letter dated 04.07.2022 to withdraw license issued to a company regarding mother's milk as Ayurveda, Siddha, Unani (ASU) drug, with immediate effect.

As per the national guidelines on Lactation Management Centre (LMC) in Public Health Facilities, Donor Human Milk (DHM) cannot be used for any commercial purpose. It is to be provided to the newborns/infants admitted in the health facility where Comprehensive Lactation Management Centre (CLMC) is situated, after all procedures enlisted in the guidelines are followed. Donation of human breast milk is to be done freely and voluntarily without any monetary benefits to the donor and with an understanding that the donated milk may be used free of cost to feed the new-borns/infants of another mother admitted in the hospital."
