Further, FSSAI has also issued an advisory dated 28.09.2022 to all the Food Safety Commissioners of States/UTs and Regional Directors to advise the licensing authorities under their jurisdiction not to allow licensing/registration for processing/sale of Mother's milk or products derived from Mother's Milk/Human Milk. FSSAI is in receipt of several complaints regarding manufacturing and marketing of mother's milk and/or products derived from mother's milk under FSSAI licenses. It has been further reported that such FBOs obtained FSSAI licenses under either standardized food product categories viz. 'Milk' or 'Dairy products' or 'Infant milk substitutes' or 'Infant foods' and thus without disclosing the details of such human milk based products being manufactured by them.

- 2. In this regard, it is clarified that any foods related to infants shall comply with the standards specified under FSS (Foods for Infant Nutrition) Regulations, 2020, which does not cover either mother's milk or any products derived from mother's milk. Further, the processing and sale of human milk is not permitted under the FSS Act, 2006 and Rules/Regulations made thereunder.
- It is also brought to your kind notice that per the National Guidelines on Lactation 3. Management Centres (LMC) in Public Health Facilities issued by Ministry of Health and Family Welfare, Government of India, donor human milk (DHM) cannot be used for commercial purposes. A copy of the said guidelines may be accessed at https://nhm.gov.in/images/pdf/programmes/IYCF/National Guidelines Lactation Man agement Centres.pdf
- 4. In view of above, I would therefore, request you to kindly advise all the Designated Officers under your jurisdiction to strictly comply with the above regulatory provisions and no license/registration for processing/sale of Mother's Milk or products derived from Mother's Milk' Human Milk should be granted to any Food Business Operators.

5. Further, in case of any report/intelligence about manufacturing of such products in the name of Milk or other standardised/proprietary products under FSSAI License stringent action including suspension/cancellation of the license/registration should be initiated immediately apart from seizure of such stocks and launching of appropriate legal proceedings against such FBOs as per the provisions of the FSS Act, 2006 and Rules/Regulations made thereunder.
